



### Enrolment Fees

<b>Application Fee</b>	\$100 Per Student	Payable when the Application for Enrolment is lodged. The Application Fee (which is non-refundable and inclusive of GST) is paid via the application portal.
<b>Acceptance Fee</b>	\$500 Per Student	Payable when accepting a place offered by the school. The Acceptance Fee is payable once in respect of each student, prior to initial commencement at the school (whether in PreKINDER or other years). The School's receipt of the 'Acceptance Form', signed and returned by parents together with payment of the Acceptance Fee, constitutes acceptance of the place offered.

### Tuition Fees and Levies

Tuition Fees and Levies are billed in four termly instalments each year for all Years (excluding Year 12). Year 12 will be billed over Terms 1,2, and 3 only, at one third of the annual fees and levies per term.

### Due Dates

Due dates for payment of each Term's Tuition Fees and Levies are as follows:

Term 1 14 February      Term 3 1 August  
Term 2 9 May            Term 4 24 October

Continuance of enrolment is contingent upon prompt payment of all Tuition Fees and Levies. The Head of School or her delegate reserves the right to withdraw a child's place if fees have not been paid 21 days from the date on which Tuition Fees fall due, or anytime thereafter.

### Sibling Discounts

A concession in the above Tuition Fees is allowable when two or more members of the immediate family concurrently attend the school, in Years K-12 and where no other concession applies, for example, a scholarship. The Sibling Discounts do not extend to Levies.

### Early Payment Discount

5% discount for Payment of Full Year of Tuition Fees by 31 January 2025. Please contact the school office on 9704 6400 if unsure of the full annual payment amount.

## Secondary Locker Fees

One off fee of \$170 (New students commencing Year 7 to Year 12).

## Additional Expenses

The Levies charge covers the provision of workbooks and craft activities (K-6), single day excursions, photocopying, and the provision of basic consumables in practical subjects (Years 7-12). They do not cover non-compulsory overnight excursions outside of metropolitan Sydney, Graduations and Formals, enrolments in TVET courses, Secondary stationery requirements or non-standard materials required in Stages 5 and 6 practical subjects.

## Payment of Fees and Levies

All Fees and Levies are payable in advance. From 2025 Fees will be billed each term. Payment may be made either at the end of the first week of each term or by instalment with either Edstart or Sentral Pay through the Sentral Parent Portal. -

There are several school approved payments methods available for Fees and Levies, which include:

1. Online, by logging into the Sentral Parent Portal or Sentral App to pay by credit card or Direct Debit. Visa, Mastercard or American Express are accepted with a 1.50% (AMEX 2.1%) surcharge on all transactions.
2. By instalment, which can also be setup within the Sentral Payment Portal or Sentral App. This arrangement will automatically debit amounts on an agreed schedule from your nominated bank account such that full payment is made within 21 days of the due date to which the fees relate. Visa, Mastercard or American Express are accepted with a 1.50% (AMEX 2.1%) surcharge on all transactions.
3. By instalment, with Edstart our additional external accounts receivable partner. Families may set up an account with Edstart via the ASG website. An Edstart account gives you the added flexibility of varying your instalment amounts from time to time whilst ensuring that all fees are paid in full by the end of each term to which they relate.

## Withdrawal from School

If a student is withdrawn from School during or at the end of Terms 1,2 and 3, one full term's notice in writing must be given to the Head of School. The notice must be given no later than one week prior to the end of the preceding term, if notice is not given, one term's fees plus GST (as applicable) will be payable.

The final dates for notice of departures during or at the end of each term are as follows. E.g. Withdrawals after 17 January 2025 will incur Term 1 and Term 2 Fees.

Term 1 17 January 2025

Term 2 4 April 2025

Term 3 20 June 2025

Term 4 25 July 2025

If a student is withdrawn from the school during or at the end of Term 4, two terms notice in writing must be given to the Head of School. The notice must be given no later than the end of the first week of Term 3. If the required notice is not given, one term's fees plus GST (as applicable) will be payable).

The final date for notice of departures during or at the end of Term 4 2025 is 25 July 2025.

As part of the NSW Education Standards Authority (NESA) requirements it is compulsory to advise the School, in the notice of withdrawal, the name of the school to which the student is being transferred.

## Overdue Accounts

If payment is not made within 21 days of the invoice due date, an overdue charge of \$100 per month which reflects (among other things) the administrative and financial cost of collecting outstanding Fees and Charges will be added to the family account. No Fee or Levy deduction can be made because of non-attendance for any reason. Leave will not be granted on a no-fee basis.
